

#### **Purpose**

The Farm and Agribusiness Management Career Development Event provides competition that fosters information assimilation, critical thinking and problem-solving skills necessary to successfully manage a farm or pursue farm business management careers. The Farm and Agribusiness Management Career Development Event enhances and encourages opportunities for all participants to receive instruction that develops farm and agribusiness management skills.

#### **Event Objectives**

The event objectives are for participants to demonstrate their ability to:

- analyze farm/ranch business management information.
- apply economic principles and concepts of farm business management to the decision making process.
- evaluate farm and agribusiness management decisions.

The Farm and Agribusiness Management portion of the CDE is expected to take from two to three hours. Specifically, for this year's event:

1. Like previous WV Farm and Agribusiness Management CDEs, this year the WV Farm and Agribusiness Management CDE will consist of multiple-choice question exercises consisting of 50 to 75 questions covering basic microeconomic and financial concepts. Participants will compete individually. There will be no team activity. However, concepts covered in past National Team Activities may be included in the WV Farm and Agribusiness Management CDE.
2. The WV Farm and Agribusiness Management CDE will cover the areas of past National Farm and Agribusiness Management CDE's: Financial Statements, Budgeting, Cash Flow Planning, Marketing, Income Tax, Investment Analysis, Risk Management, Business Organization/Land Measurement, Analyzing the Agricultural Business, Family Living, and Economic Principles.

3. Participants will be expected to interpret and analyze balance sheets, cash flow statements, income statements, enterprise budgets, partial budgets, and financial ratios.
4. Each of the Farm and Agribusiness Management CDE sections may require students to define terms (either multiple choice questions or matching terms and definitions).
